





- 1) The AQAR has been submitted to NAAC portal on 8th July, 2021.
- 2) The data compilation of AAA for academic year 2019-20 is completed.
- 3) The expert committee from KTHM College, Nashik has been invited to conduct Green and Energy Audit of the institute on 18th February 2021. Following factors were considered in the Green and Energy Audit of the institute:
